

Dear Jim.

Last year we anchored a couple of times in Troller's Cove, a tiny bay inside Island Point on Prince of Wales Island. The area is usually productive in August for both salmon and halibut, and there is a reasonable amount of wind-storm protection once we get across. (You're about due for some beautiful, sunny weather, anyway.).

This year a new forest service cabin has been built in the bay next to the one we anchored in. Thinking that we will be a mite crowded aboard "ship" and that the youths might enjoy their own cabin and skiff, I have rented the cabin for the time we will be there. I intend to get a 14-16' skiff and outboard over there either ahead of time or to tow with us. In this way we have more options. People can sleep on and fish from the Seabreeze or sleep ashore, get up late, slop around, and fish from the skiff, trading off.

I'll need to have the skiff operators learn where the rocks are in that little channel or the outboard won't operate for long. I'll plan to take an extra radio, 15-20 gallons of outboard fuel, 3 air mattresses, sleeping bags, etc.

From past experience I can say that shore parties work okay as long as the main boat party fishing activities don't get too delayed. With a shore party, we'll need to schedule times and places to be or suffer fishing time loss. Your boys all seem intelligent, so we should be able to pull this off.

We haven't mentioned price! With 6 guests in our small boat, I'll negotiate. You were \$165/person/day last year, and I would intend to keep that again for 1987. That would be 4 days  $\times$  6 guests  $\times$  \$165/day = \$3960.00.

My costs will be skiff and motors at \$100/day (say 4-5 days); cabin, \$30; fuel, \$25-30; plus extra grub, tackle, safety equipment. The \$3960.00 sounds high, though we're worth it, of course! I'll let you think it over and set a price since you could go for free if it came right down to (Relatives I've hardly met before come up and go for What do you think is fair and affordable? free.)

Besides the portable radio, the skiff would have emergency flares, etc. I'm an old "fuss budget" about trouble, I know, but kids that age can get in a lot of serious trouble fast when the outboard won't start or catches fire or \_\_\_\_.

We looked at bigger boats while we were in Seattle and almost made an offer on a 55' Stevens; but when it came right down to it, I could find enough reasons not to invest the \$250 - 300,000.00 Nice big boat, though. Maybe another year.

We're finishing teak oiling and getting ready for waxing. Have a trip in two weeks and then a 10 day gap and then no significant free time until mid-Sept.

I've reserved 3 rooms at the Super 8 for you on Tuesday night, Aug. 12.

P.S. Cabin has stove, 4 wooden bunks, outhouse, etc. Lots of clams but very subject to paralytic shellfish poison micro-organisms. The bay is bigger than the one we anchor in, but rocks around the entrance keep most people out.

Dear Jim and Norma:

Delighted to have your note and to know that I am not the only voice from the wilderness working on political committees, almost always against the current. However, the mayor's committee did capitulate relative to putting the convention center on the south side of town, for the very same reasons I said it was a bad idea a year ago. A local newspaper reporter published his notes on a lecture I had given more than 12 months before so that I didn't even have to stoop to "I told you so."

You will be pleased to hear that I am already planning my salmon and halibut campaign. For the salmon I purchased a commercially available sealine level wind reel with a built-in electric motor by Daiwa. It can handle 220 yards of 2 pound test. Has its own rechargeable battery and an AC adapter. I also purchased a level wind penn-senator which carries a little more line than a Daiwa to which I mated one of my electric mate motors. Cases and gears have been replaced on two of my other electric mate units and my Miya Epoch reel is at the factory for repairs! Your boat modifications and reel purchases will make me two rods deadly. Since we tend to eat the halibut faster than the salmon, we must catch a couple of hundred pound halibuts.

The hip is doing much better with a minimum of all day cramps, although circulation is not quite as good as before so the lower leg tends to be a little puffier. Still working on Jean to go fishing rather than grandmothering, and she hasn't said no yet.

Thanks for all the advanced planning on the reels. Some of them cost almost as much as the radar.

Incidentally, I did a planning charrett in Seattle for the Port Authority. The President of the Port Commission turned out to be one of my former MBA students, although neither of us knew that at the time I accepted the job. Had quite a lesson on current commercial fishing needs of factory ship bottom trawlers.
